

When?

- The competition opens at 8am on the first day of each calendar month and closes at 4pm on the last day of each calendar month (“Competition Period”), starting from 1 December 2018.

Who can enter?

- Anyone with an Instagram account who is over 13 years old (Note: in order to activate an Instagram account, you need to be (a) 18 years or older, or (b) 13 years or older and have your parent or guardian’s consent and have agreed to the Instagram Terms and Conditions of Use).
- Entry to the competition is free.

How to submit entries

- Follow @MosmanCouncil on Instagram and make sure your profile is public so that we can see your entries.
- Snap away within Mosman and upload your photos to Instagram using the hashtag #mosmanmoments and tag @MosmanCouncil
- Be sure to add a description or hashtag the area where the photo was taken (photos must have been taken within the Mosman local government area).
- By submitting photos using #mosmanmoments you’re accepting our terms and conditions.

Prizes

- Overall monthly winner - \$100 prepaid gift card
- Overall monthly runner-up - \$50 prepaid gift card

Judging

- At the conclusion of each competition period, one (1) entry will be selected as the overall prize winner of the competition (the “Winner”), by a Mosman Council judging panel. A further one (1) prize will be selected as the runner-up of the competition (the “Runner-up”), by the same Mosman Council judging panel.
- The judges’ decision will be final and no discussions or correspondence will be entered into.

- Failure to respond within this time frame or provide the required information will result in disqualification and forfeiture of any prize.
- Finalists will also be asked to provide a digital copy of the picture via email in a higher resolution format (minimum size accepted will be 2MB) without any watermarks.
- Confirmation of consent to the Terms & Conditions will also be a pre-requisite to eligibility for winning the prize.
