REQUEST FOR QUOTATION

In respect of

Mosman Access Strategy

A. Introduction

A1. Statement of Requirement

Mosman Council requests quotations from suitably qualified and experienced consultants to prepare and develop an Access Strategy for identified public facilities and spaces in the Mosman area.

The Access Strategy should:

- Demonstrate an understanding of the range of access issues which need to be addressed and the means by which people with specific disabilities can be independent;
- Provide guidelines for its application;
- Apply guidelines and undertake appraisals of compliance of the specified public facilities and spaces outlined below (A.2.1).
- Provide concept plans for its application;
- Prioritise recommendations for action in a realistic and sustainable manner;
- Develop a cost list of priority works;
- Comply with all relevant Australian Standards; and
- Be implemented in association with the Pedestrian Access and Mobility Plan (PAMP).
 The PAMP is a working strategic document developed by Council in 2012 to improve pedestrian access in the Mosman area.

A2. Scope

A2.1. Review access and provide specific recommendations for improvements in the following areas of Mosman:

- Military Road footpath (from Spit Junction to Centenary Circle):
- Mosman Square;
- Civic Centre:
- Mosman Seniors Centre
- Library Walk Public Toilet;
- Mosman Library;
- Art Gallery;
- Allan Border Oval (including toilet facilities and pavilion (Mosman Occasional Care);
- Raglan East and West Carpark
- Balmoral Beach (including carpark, on-street parking, toilet facilities, Balmoral Baths and Jetties*);
- Clifton Gardens (including carpark, playground and toilet facilities); and
- Rawson Park (including carpark, Drill Hall and Marie Bashir Sports Centre).
- * Detailed design for a disabled access ramp to Balmoral Baths was recently developed for Council. It is intended that this design be taken into consideration during the development of the Access Strategy. A copy will be provided to the preferred tenderer.
- A2.2. Consult with relevant stakeholders to determine locations within the above identified areas of Mosman that warrant further study. The key stakeholders include the following:
 - Council staff; and
 - Mosman Access and Mobility Community Consultative Committee.
- A2.3. Based on A2.2 develop list of recommendations for action in order or priority, estimated costing and five (5) concept designs for review by key stakeholders.

A3. Purpose of the Consultancy

The purpose of the Access Strategy is to recommend actions for accessibility improvements in the Mosman area to facilitate access for all people, including, but not limited to, people with disabilities and older people.
