CONDITIONS

- Real estate signs which are erected in air space or on land above a public road or footpath are subject to approval by Council.
- Application is to be made, on the prescribed form, together with location plans and is to be lodged with the specified fee depending on the classification of the sign.
- Prior approval of the Body Corporate/Company Secretary must be obtained for Strata Titled and Company Titled properties.
- The application must be approved prior to the erection of a sign.
- A sign erected on Council property must not under any circumstances impede pedestrian or vehicular traffic
 and accordingly a sign proposed to be erected on a public road or footpath will only be approved under
 extenuating circumstances.
- Applications for the erection of real estate signs within the air space and above public roads or footpaths will be considered on their own merits.
- If approval is granted for the erection of the sign, such approval will be on the basis that the sign will be removed from Council property or airspace by the applicant or applicants contractor within (7) seven days of exchange of contracts for the sale or lease or within (7) seven days of words to the effect that the property has been sold or leased being placed on the sign whichever is the earlier.
- If signs are not licensed or removed as required they will be removed without further notice and the person responsible for the erection of the sign will be liable to prosecution by Council.
- The applicant takes full responsibility for the erection and or fixing and regular maintenance of the sign and indemnifies Council against all claims, existing or arising later by reason of any real estate signs erected by the applicant.
- Prior to the erection of the sign, a certificate of currency evidencing that a public risk insurance policy has been enforced to the amount not less than \$10,000,000 on which Council's interests are noted indemnifying Council against any claims for injury to pedestrians or other persons' property caused by or resulting from the real estate sign being placed on Council property or in Council airspace.
- Real Estate signs in respect of residential premises will only be approved by Council if the sign cannot be
 placed within the residential premises. Real Estate signs will only be given approval to be placed directly in
 front of the premises they are advertising.

Should the above conditions not be complied with within (7) seven days of notification your licence will be cancelled and no refund will be granted.

REAL ESTATE SIGNS – DEFINITION & LICENCE FEES ON PUBLIC LAND

"Standard real estate signs" means an advertisement in respect of a place or premises to which it is affixed which contains only a notice that the place or premises is or are for sale or letting, together with particulars of the sale or letting and:

- (a) For signs placed on public land advertising the proposed sale, auction or letting of a residential property where the sign does not exceed 1.5m² the fee is \$330 per 3 month period.
- (b) For signs placed on public land or airspace advertising the sale, lease or auction of commercial premises where the sign does not exceed 4.5m² the fee is \$575 per 3 month period. Signs are not to exceed the dimensions within this category unless specific Council permission is given

Note- signs on private property are subject to the provisions of State Environmental Planning Policy (Exempt and Complying Development Codes (2008)).
